In terms of the Instruction received from the Secretary, W.B.B.P.E through the forwarding letter of provisionally approved Merit List of students for admission into Two Years D.EL.ED Course (Regular/Face-to-Face Mode) in Part-I for the Academic Session 2023-2025 vide Memo. No. 293(61)/WBBPE/D.El.Ed./33A-08/2023 Dated. 08.11.2023, I am directed to inform all the provisionally selected 1st Merit Listed Candidates that they should physically present at this Institute along with the online filled up Application form as well as all the original documents produced at the time of online application, Two Self attested photocopy of essential documents specified below and Two Pass Port Size recent Colour Photograph.

It is also being informed to the said candidates that the Last date of Admission is 23.11.2023 (Thursday) by 03:00 P.M.(Excluding Sundays & Holidays, Govt. holidays from 13.11.2023 to 16.11.2023 and 20.11.2023, within seven Working days, Time of Admission-11:00 A.M. to 03:00 P.M., in Saturdays time of admission-11:00 A.M to 01:30 P.M.). After the mentioned time limit & date no candidates from the provisionally approved 1st Merit Short List will be allowed for admission. It is further informed that having a rank in the Merit List does not guarantee admission. Confirmation of Admission is strictly subject to Physical verification of the documents mentioned below:

\* Percentage of Marks in H S or its equivalent Examination as per NCTE-Norms,\* Appropriate Recognition of the Board/Council under which s/he studied the HS (+2) or its Equivalent Examination,\* Language studied other than English,\* Perfect match of the medium of the Institution as per the List of the D El Ed Institutions, annexed to the Admission Notification of 2023-2025 with the Medium opted by the applicant,\* Upper age limit,\* Caste & PH-category certificates (where applicable),\* Id Proof ( Aadhaar Card/Voter Card or any Valid Documents),\* Date of Appointment/Joining (for Deputed Candidates),\* Proof of belongingness to Ex-Servicemen Category etc.

#### Points to be noted:

- \* Separate bond for Anti-Ragging must be submitted at the time of admission by the trainee,
- \* Rules for uniform will be supplied at the time of Admission,
- \* There is no provision of Hostel Accommodation for the Male & Female Trainees,
- \* His/her Name may be struck off from the Roll even after provisional admission for any off the following:
- a) Expecting Mothers,
- b) His/her conduct and behaviour is unsatisfactory. If he/she does not obey the rules and regulations of this institute.
- c) If he/she is medically Unfit, Candidates suffering from congenital/contagious diseases,
- d) For 15 (Fifteen) days absence from the starting of the Class of the Academic Session,
- e) If any Mark sheet/certificate submitted by the candidate is found false,

In case of any deficiency/short-coming, found out on verification at the time of admission, this D El Ed Institution will cancel his/her admission. It is further notified that after verification he/she should deposit @ Rs. 7,700/- only per candidate in advance to the Bank Account.No. 1121010438452 of R.R.ROY.GOVT. P.T.T.I. of Punjab National Bank, Krishnagar Branch (Hooghly), as admission fee for D.El.Ed Part-I.

Guidelines regarding use of Approved Merit Lists for Admission to Two Year D. EL ED. Course (Regular)—2023-2025 should strictly be followed.

You are requested to verify the uploaded/given declarations/data with the original certificates / testimonials /documents for authentication of candidature, at the time of admission.

Please confirm yourself of the authenticity of the following before issuing the order for admission:

1. i.Percentage of Marks in H.S or its equivalent Examination as per NCTE-norms, read with Admission Notification/s

#### ii.Language studied other than English

- iii.Perfect match of the medium of the Institution as per the list of the D.El.Ed Institutions, annexed to the Admission Notification of 2023-2025 with the medium opted by the applicant
  - iv.Upper age limit
  - v.Caste & Category Certificates (Where applicable)
- vi.Date of Appointment / Joining (for Deputed Candidates) along with Order for Deputation, issued by the competent authority in the district
  - vii. Proof of belongingness to Ex- Servicemen Category
  - viii. Domicile Certificate (For Admission to Santali Medium Institute/Unit only)

If any candidate is found to be inadequate in respect to any of the above noted candidate-specific stipulations, do not admit him/her. If done otherwise, the entire responsibility of such 'inauthentic admission' and consequent cancellation of admission by the Board on further verification, shall lie with you.

#### It is further clarified that:

- 2. \*No listed candidate with less than 50% (45% for the reserved category) marks in HS or its equivalent Exam should be admitted.
- 3. \*No student of other media of instructions than the language medium of the Institute as per the medium- wise list in the notification of Admission of the relevant session, will be admitted.
- 4. \*Any violation of the norms and standard, set and spelt out in the Regulatory Provisions & Guidelines issued from time to time, shall lead to cancellation of the admission.
- 5. \*All applicants for 4% (four percent) seats under Vocational Category shall, however, be considered as "Un Reserved". Candidates, selected under Vocational Category cannot be transferred to 'non-vocational category' and vice-versa.
- 6. \*Candidates under Management Quota, not over 10% of the sanctioned in-take in respect of only the Self- financed Private Unaided D El Ed Institutes, should be listed out separately and forwarded to the Board online for approval.
- 7. \* The Process of admission as per the given approved lists should be completed within seven working days from the date of publication/notification of the provisionally approved merit lists by the concerned institute.
  - \*Subsequent Lists may be released only, if seats remain vacant category-wise after the expiry of the last date of reporting for admission in terms of the First List.
  - \*And thereafter, a report of admission through our online system should be submitted to the Board for the next course of action.

After the expiry of the validity of the Approved First Merit List/s, i.e. seven working days from the date of publication of such merit lists, the Board will approve and forward the remaining merit listed candidates for the concerned Institute/s with an order to generate category wise lists for admission on the basis of the master waiting list/s (all inclusive) as per the requirement of the concerned Institute in terms of the approved intake capacity

A similar master merit list (all inclusive) will be approved and forwarded for use for admission of vocational category candidates as per the requirement of the concerned Institute in terms of the approved

intake capacity

For such second, third or subsequent merit list/s, to be generated by the concerned Institution authority in order of merit as per rules / guidelines/ order/ notifications of the Board, on the basis of the approved master waiting list/s, (One Time Despatch), the admission should be completed in not more than seven working days from the date of generation/walling up of such merit list/s.

- 8. \*Separate approval for conversion of vacant deputation-seats, reserved for primary school teachers, appointed before 03.09.2001, as per the given guidelines, is required.
- 9. \*In case of an Ex-Service-man-category applicant, his army-graduation-certificate should be treated at par with 45%/50%, as the case may be, in HS/ or its Equivalent examinations, for admission to the Course.
- 10. \*All testimonials, mark-sheets, certificates, caste-category & PH Category Certificates etc. are to be verified with the originals.
- 11. \*In case of any deficiency/short-coming, found out on verification at the time of admission, the Heads of the D.El.Ed Institutions shall cancel the admission.
- 12. Having a rank in the Merit lists does not guarantee admission. Admission is strictly subject to passing the verification and authentication of the stated percentage of marks, date of birth, category, medium, academic qualifications, validity of Boards / Councils / Universities etc. with the original certificates, documents and testimonials.
- 13. For date of birth M.P. or its equivalent examination Admit Card/Certificate shall have to be verified in addition to verification of other documents uploaded by the applicant. The date of birth shall be recorded as in the M.P. or its equivalent examination Admit Card/Certificate. In case of difference the head of the institute may treat the application invalid.
- 14. If an applicant fails at any stage of such verification of details, his/her candidature will be cancelled by the authority of the Institution without referring the matter to the WBBPE for decision. The Institution authority will only forward a report of such cancellation to the Board.
- 15. Right to being enlisted in the SC/ST/OBC-A/OBC-B/PH/EX-SERVICEMEN/IN-SERVICEMEN category is reserved for candidates belonging to such category/ies, in terms of the valid certificates, issued by the competent authorities.
- 16. An enlisted candidate may be denied admission, if there is mismatch between the statements, made and the documents, produced at the time of admission.
- 17. Only prescribed fees are chargeable.
- 18. Classes shall start in pursuance of the Circular/ Notice/ Directives/ Guidelines of the Government of West Bengal. However, institutions may take up classes immediately after admission of students.
- 19. Candidates suffering from contagious diseases like viral influenza, CORONA-viral infection etc. should not be asked to appear physically for admission. For their physical appearance, a certificate of registered medical practitioner, preferably attached to Government-run-Health Centres/ Hospitals will be required.
- 20. All the relevant testimonials should be forwarded to the relevant Board /Council for verification immediately after admission.
- 21. The List of candidates admitted should be sent online (as per instruction to be issued) to the West Bengal Board of Primary Education immediately after admission process is over.
- 22. The provisionally approved merit lists of Management Quota candidates/ In-service Category applicant shall be sent afterwards on having the same from you for approval.
