## <u>Notice regarding provisionally admission into Part-I of D.El.Ed Course (Regular Mode) through 3<sup>rd</sup></u> <u>counselling from the provisionally approved Wait Listed candidates for the Academic Session: 2024-2026</u>

In terms of the Instruction received from the Secretary, W.B.B.P.E. through the forwarding letter of provisionally approved Master Merit List of students for admission into Two Years D.El.Ed. Course (Regular/Face-to-Face Mode) in Part-I for the Academic Session 2024-2026 vide Memo. No. 593(61)/WBBPE/D.El.Ed./78P-05/2024 Dated. 06.09.2024, I am directed to inform all the following provisionally selected Wait Listed Candidates that they should physically present at this Institute Campus for **3<sup>rd</sup> counselling** along with the **online filled up Application form as well as all the original documents produced at the time of online application, Two Self attested photocopies of essential documents specified below and Two Pass Port Size recent Colour Photographs.** 

**It is also being informed to the said candidates that the date of conduct of 3<sup>rd</sup> counselling is 29.11.2024** (Friday) by 12:00 P.M. After the mentioned deadline time & date no candidates from among the following provisionally selected Wait Listed Candidates will be allowed to attend the 3<sup>rd</sup> Counselling. It is further informed that having name in the following Waiting List does not guarantee admission. Confirmation of Admission is strictly subject to availability of vacant seats in Un-reserved Category & Physical verification of the documents mentioned below:

- i. Percentage of Marks in H.S. or its equivalent Examination as per NCTE-Norms.
- ii. Appropriate Recognition of the Board/Council under which s/he studied the H.S. or its Equivalent Examination.
- iii. Language studied other than English.
- Perfect match of the medium of the Institution as per the List of the D. El. Ed. Institutions, annexed to the Admission Notification of 2024-2026 session with the Medium opted by the applicant.
- v. Upper age limit.
- vi. Caste & PH-category certificates (if applicable)
- vii. Id Proof ( Aadhaar Card/Voter Card or any Valid Documents)

## Points to be noted:

- i. Separate bond for Anti-Ragging must be submitted at the time of admission by the trainee.
- ii. Rules for uniform will be supplied at the time of Admission.

iii. There is no provision of Hostel Accommodation for the Trainees.

iv. His/her Name may be struck off from the Roll even after provisional admission for any off the following: a) Expecting Mothers.

b) His/her conduct and behavior is unsatisfactory. If he/she does not obey the rules and regulations of this institute.

c) If he/she is medically Unfit, Candidates suffering from congenital/contagious diseases.

d) For 15 (Fifteen) days absence from the date of admission.

e) If any Mark sheet/certificate submitted by the candidate is found false.

In case of any deficiency/short-coming, found out on verification during the mentioned 3<sup>rd</sup> counselling, this D.El.Ed. Institution will cancel his/her candidature. It is further notified that after verification if he/she is selected according to the available seats during this 3<sup>rd</sup> counselling, he/she should deposit @ **Rs. 7,700/-** only per candidate in advance to the Bank Account.
